The LMS platform is easily navigable by the students and is quite adaptive. The LMS platform comes in both android and iOS versions in addition to the desktop version.

Accessibility across Devices and Mobile Learning: Our Learning Management System (LMS) is designed with a focus on accessibility and flexibility, ensuring that learning can happen anytime, anywhere. We have a user-friendly LMS platform built with a UI which can be customized by each faculty based on the course requirements. Video conferencing and live chat facilities are integrated with the LMS which helps to deliver Video lectures & other student engagement activities. The platform is being hosted on AWS Cloud in India and has 1Gbps of Internet bandwidth that can be increased as per future requirements.
